

**Child's Play Buddi Box Photo Sweepstakes
Official Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE IN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

INTERNET ACCESS AND A VALID INSTAGRAM ACCOUNT ARE REQUIRED.

EACH WINNER WILL BE REQUIRED TO RESPOND TO WINNER NOTIFICATION AND OTHER COMMUNICATIONS FROM SPONSOR (DEFINED BELOW) WITHIN FORTY-EIGHT (48) HOURS ACCORDING TO THE NOTICE(S) FROM SPONSOR OR PRIZE MAY BE FORFEITED (IN SPONSOR'S SOLE DISCRETION).

THIS SWEEPSTAKES IS IN NO WAY SPONSORED, ENDORSED OR ADMINISTERED BY, OR ASSOCIATED WITH INSTAGRAM, LLC ("INSTAGRAM").

BY INCLUDING THE REQUIRED TAGS IN AN ENTRY POST (BOTH AS DEFINED BELOW), YOU ENTER THIS SWEEPSTAKES AND YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO SPONSOR FROM YOU, A LIMITATION OF YOUR RIGHTS AND REMEDIES, BINDING ARBITRATION OF CLAIMS, WAIVER OF CLASS ACTION CLAIMS, AND WAIVER OF THE RIGHT TO TRIAL BY JURY.

OVERVIEW: The Child's Play Buddi Box Photo Sweepstakes ("**Sweepstakes**") is sponsored by Orion Distribution Company LLC ("**Sponsor**"). The Sweepstakes begins at 12:00:00 a.m. Pacific Time ("**PT**") on May 15, 2019, and ends at 11:59:59 p.m. PT on June 7, 2019 ("**Sweepstakes Period**").

If you satisfy the eligibility requirements, as described in more detail below, during the Sweepstakes Period, eligible individuals may enter the Sweepstakes by taking a photo of himself/herself (i) in the Child's Play movie Buddi box standee/display at a participating theater or (ii) with the Child's Play movie webpage (<https://childsplaythemovie.com/sweepstakes>) visible on the monitor of his/her computer or other device ("**Photo**") and then posting the Photo from his/her Instagram account with the required tags: @ChildsPlayMovie, #ChildsPlayMovie, #ChildsPlayBuddiSweeps, and #Sweepstakes ("**Required Tags**"). The Photo must comply with these Official Rules, including the Submission Requirements set forth below (see below for important Submission Requirements for your Photo before entering).

Following the conclusion of the Sweepstakes Period, Sponsor will select three (3) winners (subject to verification) through a random drawing from among all eligible entries received. Participation in this Sweepstakes by posting the Photo with the Required Tags constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of Sponsor, which are final and binding in all respects.

ELIGIBILITY: This Sweepstakes is open only to legal residents of one (1) of the fifty (50) United States or the District of Columbia ("**Territory**") who are eighteen (18) years old or older and the age of majority in their state or jurisdiction of primary residence. To enter, participants must be a registered user of Instagram in good standing as of the date of entry and throughout award of the prize in this

Sweepstakes. Corporate entities are not eligible and have no right to claim any prize won by their employees. Employees, officers, members, directors, managers, agents, and representatives of Sponsor, Metro-Goldwyn-Mayer Studios Inc., and their respective parent companies, owners, affiliates, subsidiaries, divisions, successors in interest, corporate partners, advertising and promotion agencies, and any other party participating in the design, administration, or promotion of this Sweepstakes (collectively, along with Instagram, the “**Released Parties**”), or a member of the immediate family (any parent, child, sibling, spouse, or domestic partner, regardless of where they live) or any individual living in the same household of such person (whether related or not) are not eligible. This Sweepstakes is void outside of the Territory and where prohibited by law.

HOW TO ENTER: If you meet the eligibility requirements, you may enter this Sweepstakes by first taking a Photo of yourself either (i) in the Child’s Play movie Buddi box standee/display at a participating theater or (ii) with the Child’s Play movie webpage (<https://childsplaythemovie.com/sweepstakes>) visible on the monitor of your computer or other device. The Photo must comply with these Official Rules, including the Submission Requirements set forth below. Then, you can enter the Sweepstakes by logging into your account on Instagram and making a public post during the Sweepstakes Period that contains your Photo along with each of the Required Tags (any such post, an “**Entry Post**”). Your Entry Post must be posted during the Sweepstakes Period to be eligible in this Sweepstakes. Adding the Required Tags to a post or photo previously posted on an Instagram account will not earn an entry in this Sweepstakes. In posting an Entry Post, you may have the opportunity to include other content (such as images, captions, or text) in addition to the Entry Post (collectively, with the Entry Post, “**Entrant Content**”). All Entrant Content must comply with these Official Rules (including, without limitation, the Submission Requirements section below) and the Instagram Terms of Service (available at <http://instagram.com/about/legal/terms/>). Your Entry Post will not be deemed an entry in the Sweepstakes until Sponsor verifies that it meets all the Submission Requirements detailed below; but the substantive content of the Entry Post will not otherwise affect your chances of winning.

Entry Posts must be received and identifiable by Sponsor during the Sweepstakes Period or they will be void. Entries are “received” when Instagram’s database records the completed Entry Post and the Entry Post is viewable by Sponsor. Other proof of submitting an entry (such as a printed or copied screenshot of your Instagram feed) does not constitute actual receipt of the entry for purposes of this Sweepstakes. Your Entry Post must remain active on your Instagram account and viewable to Sponsor through winner selection and prize award for this Sweepstakes. Sponsor may not be able to view purported Entry Posts or otherwise receive entries or detect participation from Instagram users whose accounts are set to “private” (i.e., where the user has set his or her account so that only people the user has approved can view their posts) due to the way Instagram operates its service. It is each entrant’s responsibility to timely set his or her account settings so that Sponsor is able to view his/her Entry Post. Sponsor is not responsible for misspellings, typographical errors, or other issues that may affect a purported Entry Post from being located using a search to find eligible entries. Sponsor, at its sole discretion, may accept or disqualify a purported Entry Post that omits one of the Required Tags or contains any technically incorrect Required Tag. Purported Entry Posts that are not both actually visible and received by Sponsor during the Sweepstakes Period will not be entered into the Sweepstakes. Purported Entry Posts identified or received outside the Sweepstakes Period will be void. Each entrant must be the rightful owner of the Instagram account, and corresponding email account, utilized for entry.

Limit one (1) entry per person and per Instagram account in this Sweepstakes. Subsequent attempts made by the same individual to submit multiple entries in violation of this condition by any

methods or means are void and persons engaging in such conduct may, in Sponsor's sole discretion, be disqualified. Normal Internet access and usage charges imposed by your Internet Service Provider may apply. Entry Posts must be submitted and received by Sponsor during the Sweepstakes Period and in strict accordance with the instructions and restrictions in these Official Rules. For purposes of this Sweepstakes, an Entry Post is "received" when Instagram publishes your Entry Post and it is actually visible to Sponsor. Other proof of submitting or attempting to submit an entry (such as, without limitation, a screenshot of your purported Entry Post) does not constitute proof of actual receipt of the entry for purposes of this Sweepstakes. Those who do not abide by these Official Rules or the instructions of Sponsor or its representatives and provide all required information may, in Sponsor's sole discretion, be disqualified and any entry by such person deemed void. Entries that are fraudulent, forged, altered, incomplete, lost, late, misdirected, mutilated, illegitimate, incomprehensible, garbled, or generated by a macro, bot, or other automated means will not be accepted and will be void. Entries or participation made by you on behalf of any other individual or any entity or group, made by another on your behalf, or originating at any online service other than Instagram (including, without limitation, through a commercial promotion subscription, notification, or entering service) will be declared invalid and disqualified for this Sweepstakes. As a condition of entering the Sweepstakes, without limiting any other provision in these Official Rules, each entrant gives consent for Sponsor and its agents to obtain and deliver his or her name, address, and other information and content to third parties for the purpose of administering this Sweepstakes and complying with applicable laws, regulations, and rules.

SUBMISSION REQUIREMENTS: Your Entrant Content must meet all of the requirements in these Official Rules, including the following (all as determined by Sponsor in its sole discretion), or the associated entry may be disqualified:

- Entry Post must contain the Required Tags: @ChildsPlayMovie, #ChildsPlayMovie, #ChildsPlayBuddiSweeps, and #Sweepstakes.
- If your Entrant Content depicts or mentions any identifiable person other than you, you agree that (a) such person is 18 years old or older and the age of majority in his or her state of residence and you have that person's approval to include his or her name, likeness, or image in the Entrant Content and submit it in this Sweepstakes and can provide Sponsor proof of that approval in writing upon Sponsor's request and within the timeframe requested or (b) such person is your own minor child or ward and you are capable of granting such approval on behalf of him or her.
- Your Entrant Content must be original to you (or in the public domain) and must not infringe, misappropriate, or violate any rights of any third party including, without limitation, copyright (including moral rights), trademark, trade secret, or rights of privacy or publicity. No other person or entity may have rights to your Entrant Content. You may, however, make positive, non-disparaging reference to the motion picture Child's Play ("Film") or characters and plot points therefrom in your Entrant Content, but may not include any clips or music from the Film.
- All Entrant Content must comply with any terms, policies or guidelines applicable to your use of Instagram, including the Instagram Terms of Service (<http://instagram.com/about/legal/terms/>).
- Entrant Content must not create or imply any association between Sponsor and any individual or entity or his, her, or its products or services.
- Entrant Content must not contain any commercial or corporate advertising (including, without limitation, corporate logos, brand names, and slogans), recognizable branded products, or commercial artwork.
- Entrant Content must be unpublished and not have been submitted in any other sweepstakes, contest, promotion, or competition.
- Entrant Content must be suitable for presentation in a public forum.

- Entrant Content must not include information or content that is false, fraudulent, deceptive, misleading, defamatory (including trade libelous), disparaging, unlawfully harassing, threatening, profane, obscene, pornographic, hateful, indecent, inappropriate, or injurious to any Released Party or any other party.
- Entrant Content must not contain or describe any harmful or illegal activity or content or in any way violate any federal, state, or local laws, rules, or regulations.
- Entrant Content must not suggest, depict, or describe any inappropriate, unlawful, or dangerous behavior or use of Sponsor's products or services or any other products or services.
- **You agree that your participation in the Sweepstakes and agreement to these Official Rules and any Released Party's display and use of the Entrant Content permitted under these Official Rules will not violate any agreement to which you are a signatory or party.**
- **To the fullest extent permitted by applicable law, you agree to indemnify the Released Parties against any and all claims from any third party for any use or reuse by any Released Party of the Entrant Content permitted under these Official Rules.**

Sponsor reserves the right in its sole discretion to disqualify from the Sweepstakes any entrant whose Entrant Content refers, depicts, or in any way reflects negatively upon a Released Party, the Film, the Sweepstakes, or any other person or entity or does not comply with any provision of these Official Rules (including the above Submission Requirements), all as determined by Sponsor in its sole discretion.

ODDS AND WINNER SELECTION/NOTIFICATION: Following the close of the Sweepstakes Period, three (3) potential winners will be selected through a random drawing from among all eligible entries received. The drawing will take place within approximately one (1) business day of the close of the Sweepstakes Period. Odds of winning a prize depend on the number of eligible entries received for the Sweepstakes. Within approximately one (1) day of the prize drawing, Sponsor will attempt to contact each potential winner. Sponsor may contact a potential winner by posting a comment on the potentially winning Entry Post on Instagram instructing the potential winner to contact Sponsor through Instagram's direct message feature or through contact information provided in such comment. In addition, Sponsor may also or instead elect (but is under no obligation) to make initial contact with each potential winner using Instagram's direct message feature. Entrants are encouraged to monitor the Instagram account used for entry for correspondence from Sponsor.

Each potential winner will be required to respond to Sponsor as instructed within forty-eight (48) hours of Sponsor posting a comment on the potentially winning Entry Post or otherwise contacting the potential winner.

If any prize, prize notification, or Sweepstakes-related communication is rejected, faulty, or returned as undeliverable or if a potential winner does not timely respond according to the notification's or Sponsor's instructions or otherwise fails to comply with these Official Rules, the prize may, in Sponsor's sole discretion, be forfeited and an alternate winner may be selected (time permitting). Upon prize forfeiture, no compensation will be given and Sponsor will have no responsibility or liability to that participant. To claim a prize, each potential winner must follow the directions in his or her notification. Sponsor reserves the right to modify the notification procedures in connection with the selection of an alternate potential winner, if any.

Each potential prize winner may, in Sponsor's sole discretion, be required to complete, sign, have notarized (if applicable) and return an Affidavit of Eligibility and Liability/Publicity Release (unless prohibited by law) and tax documents, if applicable (collectively, "**Prize Winner Documents**") within

the time frame specified and in the form provided by Sponsor, without revision, or prize may be forfeited. The Prize Winner Documents, if applicable, must be received by Sponsor within forty-eight (48) hours of Sponsor sending the documents to each potential winner or other time frame as stated in the Prize Winner Documents, or prize may be forfeited and alternate winners may be selected.

The prize claim and Prize Winner Documents are subject to verification by Sponsor. The prize, if legitimately claimed, will be awarded. Sponsor will not be obligated to pursue more than three (3) alternate winners (time permitting) for any reason, in which case that prize may go unawarded.

PRIZE & APPROXIMATE RETAIL VALUE (“ARV”):

Prize: One (1) winner, subject to verification, will receive a prize consisting solely of one (1) life-size replica Buddi doll. Two (2) winners, subject to verification, will receive a prize consisting solely of one (1) Child’s Play prize pack, including one (1) enamel pin, one (1) vacuform mask, one (1) film poster, and one (1) air freshener.

ARV of life-size replica Buddi doll: \$500; ARV of each Child’s Play prize pack: \$50; total ARV of all prizes: \$600.

All prize details not specifically stated in these Official Rules will be determined by Sponsor in its sole discretion. All taxes (federal, state, provincial and local), as well as any expenses associated with prize acceptance and use and not specified in these Official Rules as being provided as part of the prize are the sole responsibility of the winners. Any mailed prize elements will only be mailed to a confirmed winner’s address in the Territory, unless otherwise agreed to by Sponsor. Sponsor is not responsible for and will not replace any lost, mutilated, or stolen prize or prize component, or any prize component that does not reach a winner because of incorrect or changed contact information. If a winner does not accept or use the entire prize, the unaccepted or unused part of the prize will be forfeited and Sponsor will have no further obligation with respect to that prize or portion of the prize. Sponsor is not responsible for any inability of a winner to accept or use the prize (or portion thereof) for any reason. No transfers, prize substitutions or cash redemptions will be made, except at Sponsor’s sole discretion. Sponsor reserves the right to substitute any stated prize or portion thereof with another prize or portion thereof of equal or greater value for any reason, including, without limitation, prize unavailability. No more than the stated prize will be awarded. Entrants waive the right to assert, as a cost of winning the prize, any and all costs of verification and redemption or travel to claim the prize and any liability and publicity which might arise from claiming or seeking to claim said prize.

LIMITATION OF LIABILITY:

TO THE FULLEST EXTENT PERMITTED UNDER APPLICABLE LAW, EACH ENTRANT AGREES TO RELEASE, HOLD HARMLESS, AND INDEMNIFY EACH OF THE RELEASED PARTIES FROM AND AGAINST ANY LIABILITY WHATSOEVER FOR INJURIES OR DAMAGES OF ANY KIND SUSTAINED IN CONNECTION WITH THE ACCEPTANCE, USE, MISUSE, OR AWARDED OF THE PRIZE OR WHILE PREPARING FOR, PARTICIPATING IN, AND/OR TRAVELING TO OR FROM ANY PRIZE- OR SWEEPSTAKES-RELATED ACTIVITY INCLUDING, WITHOUT LIMITATION, ANY INJURY, DAMAGE, LOSS, DEATH OR ACCIDENT TO/OF PERSON OR PROPERTY. THE LIMITATIONS SET FORTH IN THIS SECTION WILL NOT LIMIT OR EXCLUDE THE RELEASED PARTIES’ LIABILITY FOR PERSONAL INJURY OR TANGIBLE PROPERTY DAMAGE CAUSED BY THE RELEASED PARTIES, OR FOR THE RELEASED PARTIES’

GROSS NEGLIGENCE, FRAUD, OR INTENTIONAL, WILLFUL, MALICIOUS, OR RECKLESS MISCONDUCT.

TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, EACH WINNER AGREES THAT THE PRIZE IS PROVIDED AS-IS WITHOUT ANY WARRANTY, REPRESENTATION, OR GUARANTEE, EXPRESS OR IMPLIED, IN FACT OR IN LAW, WHETHER NOW KNOWN OR HEREINAFTER ENACTED, RELATIVE TO THE USE OR ENJOYMENT OF THE PRIZE, INCLUDING, WITHOUT LIMITATION, ITS QUALITY, MERCHANTABILITY, OR FITNESS FOR A PARTICULAR PURPOSE.

EACH ENTRANT UNDERSTANDS AND AGREES THAT ALL RIGHTS UNDER SECTION 1542 OF THE CIVIL CODE OF CALIFORNIA AND ANY SIMILAR LAW OF ANY STATE OR TERRITORY OF THE UNITED STATES ARE HEREBY EXPRESSLY WAIVED BY HIM/HER. SECTION 1542 READS AS FOLLOWS:

“CERTAIN CLAIMS NOT AFFECTED BY A GENERAL RELEASE. A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY.”

ADDITIONAL DISCLAIMERS:

Released Parties are not responsible and/or liable for any of the following, whether caused by a Released Party, the entrant, or by human error: entries that are submitted by illegitimate means (such as, without limitation, by an automated computer program) or entries in excess of any stated limit; any lost, late, incomplete, illegible, unintelligible, garbled, mutilated, or misdirected entries, emails, Instagram direct messages, mail, or Sweepstakes-related correspondence or materials or postage-due mail; any error, omission, interruption, defect or delay in transmission or communication; viruses or technical or mechanical malfunctions; interrupted or unavailable cable or satellite systems; errors, typos, or misprints in these Official Rules, in any Sweepstakes-related advertisements, or other materials; failures of electronic equipment, computer hardware, or software; lost or unavailable network connections, or failed, incorrect, incomplete, inaccurate, garbled or delayed electronic communications. Sponsor reserves the right to restrict or void entries or participation from any Instagram account, email, or other identifiable source if any suspicious entry and/or participation is detected. Sponsor reserves the right to restrict or void online entries or participation from any Instagram account or other identifiable source if any suspicious entry and/or participation is detected. Sponsor reserves the right, in its sole discretion, to void entries of any entrant who Sponsor believes has attempted to tamper with or impair the administration, security, fairness, or proper play of this Sweepstakes. Sponsor's failure to or decision not to enforce any provision in these Official Rules will not constitute a waiver of that or any other provision. In the event there is an alleged or actual ambiguity, discrepancy, or inconsistency between disclosures or other statements contained in any Sweepstakes-related materials and/or these Official Rules (including any alleged discrepancy or inconsistency within these Official Rules), it will be resolved by Sponsor in its sole discretion. Entrants waive any right to claim ambiguity in the Sweepstakes structure or these Official Rules. If Sponsor determines, at any time and in its sole discretion, that a winner or potential winner is ineligible, in violation of these Official Rules, or engaging in behavior that Sponsor deems obnoxious, inappropriate, threatening, illegal or that is intended to annoy, abuse, or harass any other person, Sponsor reserves the right to disqualify that winner or potential winner, even if the disqualified winner or potential winner may have been notified or displayed or announced anywhere. The Released Parties are not responsible and will have no liability for any purported Entry Post or other content that is removed from Instagram for any reason at any time, including removal by Instagram of content that would otherwise qualify as an Entry Post in response to such content being "flagged" or reported as inappropriate. The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules will otherwise remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. The Released Parties are not responsible for any changes to or unavailability of Instagram that may interfere with the Sweepstakes (including any limitations, restrictions, or conditions placed upon

Sponsor's ability to use Instagram for the Sweepstakes as set forth herein that are not acceptable to Sponsor) or ability of entrant to timely enter, receive notices or communicate with Sponsor, in which case Sponsor, in its sole discretion, may terminate or modify the Sweepstakes. If the Sweepstakes is not capable of running as planned for any reason, Sponsor reserves the right, in its sole discretion, to cancel, modify or suspend the Sweepstakes and award the prize from eligible, non-suspect entries received prior to cancellation, modification, or suspension or as otherwise deemed fair and appropriate by Sponsor. If any person supplies false information, obtains entries by fraudulent means, or is otherwise determined to be in violation of these Official Rules in an attempt to obtain the prize, Sponsor may disqualify that person and seek damages from him or her and that person may be prosecuted to the full extent of the law. In the event of a dispute concerning the identity of a participant, the participant will be declared to be the registered account holder of the email address associated with the Instagram account used at the time of entry, but only if that person meets all other eligibility criteria, otherwise the entry may, in Sponsor's sole discretion, be disqualified and any potential prize won forfeited.
